#### Why Change The AGS By-laws?

During my tenure as the AGS Secretary, the AMA requested all chartered clubs to send a copy of their by-laws when they rechartered. In addition, the AMA provided each club with sample by-laws. These can be found on the AMA web site. They encouraged each club to review the sample by-laws and compare them to their club by-laws. Some of the articles in the sample by-laws were strongly recommended for adoption by each club. The results of the comparison, the addition of the recommended articles, and some general cleanup can be found in the proposed by-laws found in *The Connector*. The Board of Directors has reviewed these by-laws and will be requesting that our current by-laws be amended. (To see how we do this, please read article 11.1 in the attached by-laws.)

## Aeroguidance Society Inc. By-laws Updated June-2003

#### **Article 1 - ORGANIZATION**

- 1.1 The name of this organization shall be: Aero Guidance Society, Incorporated., hereafter referred to as AGS
- 1.2 The organization shall be a chartered club of the Academy of Model Aeronautics (AMA).

#### **Article 2 - PURPOSE**

2.1 The primary purpose of the AGS shall be to advance and promote the art of building and operating radiocontrolled aircraft.

#### Article 3 - MEMBERSHIP

- 3.1 Regular and Associate Members All Regular and Associate Members shall be actively interested in radio-controlled aircraft. They must be AMA licensed and FCC licensed if required. All members are expected to fulfill their obligations to the corporation such as committee assignments and assessments. All members shall agree to abide by the AGS by-laws, the AGS field rules, the by-laws of the AMA, and the AMA national model aircraft safety code.
  - 3.2 New Members Prospective new members become Associate Members for six (6) months by paying one half (1/2) of the annual dues, as defined in Article 9, and the full amount of any Special Assessment, if required. Associate Members have all rights and duties of Regular Members except voting rights. During the seventh month, his membership shall be discussed and voted upon by secret ballot. Former Regular Members applying for membership shall be immediately eligible for Regular Membership at any regular meeting. A two-thirds (2/3) vote of a quorum (Refer to Article 4 Section 5) shall be required for Regular Membership.
  - 3.3 Termination of Membership Involuntary termination of membership shall result, subject to the approval by the Board of Directors, when a member has failed to meet his obligations.
- 3.4 Student Member A Regular Member attending school as a full-time student during the dues year. He shall have voting rights only after he has reached eighteen (18) years of age.
- 3.5 Family Member A regular Member who is a dependent of and resides in the home of a Regular Member. He shall have voting rights only after he has reached eighteen (18) years of age.
- 3.6 Senior Member A Regular Member who becomes sixty-five (65) years old and shall be a member of the AGS for at least ten (10) years during the next dues year.

#### Article 4 - MEETINGS

- 4.1 All meetings shall be conducted according to Robert's Rules of Order.
- 4.2 The Annual Meeting of the AGS shall be held on the first regular meeting day in October. Every member in good standing shall receive at his mailing or email address as it appears in the membership roster of the AGS, a notice telling the time and place of such annual meeting. This notice shall also include the nominees recommended by the Nominating Committee. All nominees for office must be announced at the regular meeting preceding the annual meeting.
- 4.3 Regular meetings shall be held at a time and place designated by the AGS officers and published in the AGS newsletter. All members shall be notified prior to any regular meeting which is postponed or canceled.
  - 4.4 Special meetings shall be called at the discretion of the President with due notification in writing.
- 4.5 The presence of the lesser of either fifteen (15) voting members or fifty (50) percent of the voting members, two (2) of which must be officers, shall constitute a quorum and shall be necessary to conduct the business of the AGS.

#### **Article 5 - VOTING**

- 5.1 At all meetings, votes shall be taken by show of hands. For the election of officers and new members, secret ballots shall be provided.
  - 5.2 At any regular or special meeting, if a voting member so requests, any question may be voted upon by secret ballot.
  - 5.3 Voting privileges are extended to all Regular Members in accordance with New York State Law.

#### Article 6 - BOARD OF DIRECTORS

- 6.1 The Board of Directors shall consist of seven (7) Regular Members, (President, Vice President, Secretary, Treasurer, Past President and two (2) elected members at large) and have control and management of the affairs and business of the AGS. The two Members at large will be elected on alternate years at the Annual Meeting, for two year terms. Such Board of Directors shall act in the name of the AGS when it shall be regularly convened by its chairman after due notice to all of the Board Members of such meeting.
- 6.2 Four (4) members of the Board of Directors shall constitute a quorum. Official decisions may be made by a quorum at a Board of Directors meeting. These decisions shall be consistent with the stated purposes and objectives of the AMA as set forth in its by-laws and, where those by-laws are not specified, vested in sound discretion of the Board of Directors. These meetings shall be held at the discretion of the President.
- 6.3 Each Director shall have one vote and such voting may not be done by proxy.
- 6.4 The Board of Directors may make such rules and regulations covering its meetings as it may in its discretion determine necessary.
- 6.5 Vacancies in the said Board of Directors shall be filled by a vote of the majority of the remaining members of the Board of Directors for the balance of the term of the vacated office.
- 6.6 The President of the AGS, by virtue of his Office, shall be Chairman of the Board of Directors. The Secretary of the AGS shall perform the secretarial duties required at the meetings of the board.
- 6.7 A Director may be removed when sufficient cause exists for such removal. The Board of Directors may entertain charges against any Director. A Director may be represented by counsel upon any removal hearing. The Board of Directors shall adopt such rules as it may in its discretion consider necessary for the best interests of the AGS for this hearing.
- 6.8 The immediate Past President is automatically elected to the Board of Directors.
- 6.9 Minutes shall be taken of all Board meetings and read to the general membership as part of the business of the next regular meeting.

#### **Article 7 - OFFICERS**

- 7.1 All officers of the AGS shall serve for one (1) dues year and are limited to two (2) consecutive terms in the same office.
- 7.2 The election of officers shall be held at the Annual Meeting and the nominations shall be made by a committee appointed beforehand for that purpose, or by Regular members following the report of the Nominating Committee.
- 7.3 Election to office requires a majority vote of a quorum of members. In the case of more than two (2) nominees and no majority vote, there shall be a new ballot with the two nominees with the greatest number of votes in contention.
- 7.4 The officers of the AGS shall be as follows:
  - a. President
  - b. Vice President
  - c. Secretary
  - d. Treasurer
- 7.5 The President shall preside at all meetings.
  - a. He shall by virtue of his office be Chairman of the Board of Directors.
  - b. He shall establish any committees, temporary or permanent, and appoint their chairman.
  - c. He shall see that any books, reports, and certificates as required by law are property kept or filed.
  - d. He shall be one of the officers who may sign the checks or drafts of the AGS.
  - e. He shall have such powers as may be reasonably construed as belonging to the chief executive of any organization.
  - He shall appoint an AMA-qualified Contest Director for each AMA sanctioned event.
  - q. He shall have discretionary spending of up to \$50.00 for any single purchase without requiring membership approval.
- 7.6 The Vice President shall assume the President's duties in the absence of the President and has all the same rights and powers as the President.
- 7.7 The Secretary shall keep the minutes and records of the AGS in appropriate books.
  - a. He shall file any certificate required by any statute, federal or state.
  - b. He shall give and serve all notices to members of the AGS.
  - c. He shall be the official custodian of the records of the AGS.
  - d. He may be one of the officers permitted to sign the checks or drafts of the AGS.
  - e. He shall present to the membership at any regular meetings any significant communication addressed to him as Secretary of the AGS.

- f. He shall attend to all correspondence of the AGS and shall exercise all duties incident to the office of the Secretary.
- g. He shall have discretionary spending of up to \$50.00 for any single purchase without requiring membership approval.
- 7.8 The Treasurer shall have the care and custody of all moneys belonging to the AGS and shall be solely responsible for such moneys or securities of the AGS.
  - a. He must be one of the officers who shall sign checks or drafts of the AGS. No special funds may be set aside that shall make it unnecessary for the Treasurer to sign the checks issued upon it.
  - b. He shall render, at stated periods as the Board of Directors shall determine, a written account of the finances of the AGS and such report shall be physically affixed to the minutes of the Board of Directors at such meeting.
  - c. He must present a detailed report at the Annual Meeting which outlines income and expenses for the fiscal year, which shall be affixed to the minutes of that meeting.
  - d. He shall exercise all duties incident to the office of the Treasurer.
  - e. He shall have discretionary spending of up to \$50.00 for any single purchase without requiring membership approval.
    - 7.9 Officers shall by virtue of their office be members of the Board of Directors.
- 7.10 All Officers and the Newsletter Editor, shall be exempt from paying dues while in office, and the AGS will reimburse the President for his AMA dues. All officers are subject to paying any and all Special Assessments.
- 7.11 An audit of the AGS' financial records and assets shall be conducted by an audit team consisting of the President, Vice President and Secretary and shall be completed each year before the Annual Meeting.

#### **Article 8 - COMMITTEES**

- 8.1 All committees of the AGS shall be appointed by the President and their term of office shall be for a period of one (1) year or less if sooner terminated by the action of the President. The responsibility of each committee shall be defined and documented by the President.
  - 8.2 The Permanent committees shall be:
  - a. Contest
  - b. Program
  - c. Field
  - d. Membership
  - e. Historian
  - f. Nominating
  - a. Activities
  - h. Newsletter Editor
  - i. Public Relations
  - j. Librarian
  - k. Sound
  - I. Safety
- 8.3 A nominating committee consisting of three (3) members shall be appointed at least six (6) weeks prior to the Annual Meeting. At least one (1) candidate for each office shall be recommended.

#### **Article 9 - DUES and ASSESSMENTS**

- 9.1 Dues will be imposed upon the members of the AGS in order to meet operating expenses.
- 9.2 The dues year begins November 1st and ends the following October 31st.
- 9.3 Dues are to be paid in advance at the October and April meetings. The amount paid at the October meeting is determined by dividing the total amount due (membership plus special assessment, as applicable) in half and rounding up to the nearest dollar, the balance being payable in advance at the April meeting.
  - 9.4 Regular Member dues shall be sixty-six dollars (\$66) per dues year.
  - 9.5 Senior Member dues shall be fifty-four dollars (\$54) per dues year.<sup>1</sup>
  - 9.6 Student Member dues shall be eighteen dollars (\$18) per dues year.
- 9.7 Family Member dues shall be thirty dollars (\$30) per dues year. A Family Member who is a full time student or under the age of eighteen (18) shall pay the same dues as a Student Member.
- 9.8 The total dues for a family living in the same household shall not exceed ninety-six dollars (\$96) plus special assessments.
- 9.9 Any Regular Member, excluding Student and Family Members, paying annual dues in full by October 31st will be given a six dollar (\$6) discount.
- 9.10 Special Assessments may be imposed upon the members of the AGS.<sup>2</sup> These Special assessments must be for a defined purpose.
- 9.11 Special Assessments shall be approved by a two-thirds (2/3) majority vote of a quorum at any regular or special meeting following written notification.

- 9.12 Special assessments will not be levied on Student and Family Members.
- 9.13 Any member more than two (2) months delinquent in meeting his financial obligations may be removed from the AGS roles as provided for in Article 3.

#### **Article 10 - AGS ACTIVITIES**

- 10.1 The AGS shall annually conduct:
  - a. An AMA sanctioned contest
  - b. A social party.
  - c. A closed contest for members.

#### **Article 11 - AMENDMENTS**

11.1 Amendments may be made to the by-laws at any regular or special meeting of the membership, provided the members have all been notified in writing at least three (3) days in advance that an amendment is to be considered. Copies of the proposed amendment shall be provided to all directors or to any members who may request same. Approval shall be by two-thirds (2/3) majority vote of a quorum at any regular or special meeting following written notification.

#### **Article 12 - DISSOLUTION OF THE ORGANIZATION**

- 12.1 Dissolution of the AGS can be accomplished at any regular or special meeting of the membership provided the members all have been notified of the reason for the dissolution in writing at least seven (7) days in advance of that meeting. Dissolution shall be by a positive vote of three fourths (3/4) of the attendees at that meeting called for that purpose.
- 12.2 Upon dissolution, the AGS assets in excess of liabilities will be donated to the Academy of Model Aeronautics, Inc. or to such organization with purposes similar to the purposes of this Corporation, as the Board shall determine.

#### **Article 13 - INCORPORATION**

13.1 The incorporation of this membership shall be a minimum of four (4) of the seven (7) elected officers.

#### **Article 14 - DURATION**

14.1 The duration of this corporation shall be perpetual.

#### Article 15 - LOGO

15.1 The official corporate logo is:



#### Article 16: RESIGNATION, TERMINATION, DISCIPLINARY ACTION, EXPULSION AND REINSTATEMENT OF MEMBER-SHIP

- 16.1 Any member in good standing may resign his/her membership by giving written notice to the AGS.
- 16.2 If any member ceases to have the qualification necessary for membership in the AMA, his/her membership in the AGS shall thereby terminate, subject to reinstatement upon restoration of eligibility.
- 16.3 This section provides for enforcement of the Safety Rules that are related to flying activities. Any other unacceptable behavior by an individual member or members, as defined by the Board of Directors, become the responsibility of the Board of Directors. Any individual may be expelled from membership from the AGS by a two-thirds (2/3) majority vote of the Board of Directors if, in the Board of Directors' determination, such individual willfully commits any act or omission which is a violation of any of the terms of these Articles of Incorporation and By-laws, or the Rules of the AMA, or which is detrimental the AGS, the AMA, or to model aviation.
- 16.4 Any member who is expelled from membership may be reinstated to membership only by two-thirds (2/3) majority vote of the Board of Directors.

16.5 The Board of Directors shall have the discretionary authority to provide for and to impose disciplinary action for such acts or omissions, which do not justify expulsion from membership.

#### Article 17: GRIEVANCE PROCEDURE (FLIGHT AND GROUND SAFETY RULES)

#### 17.1 Purpose

The grievance procedure provides a mechanism to enforce existing safety rules by providing a progressive disciplinary system when needed. Although most complaints can be resolved informally, if a complaint is serious or cannot be resolved informally, the matter should be referred to the Safety Committee for its consideration by

means of a Grievance Form to be filled out and turned into the Safety Committee Chairman. At least one witness is required to sign the Grievance Form.

#### 17.2 Safety Committee

The Safety Committee shall use its judgment in carrying out action on the following:


- (a) A grievance form will be filled out and turned into the Safety Committee Chairman. At least one witness is required.
- (b) FIRST VIOLATION
- a. Viewpoints of both complainants and accused will be considered.
- b. Complainant's name will be disclosed.
- c. A verbal reprimand will be given to the accused by the Safety Committee, and this will be recorded in the Committee files.
- (c) SECOND VIOLATION
- a. Complainant's name will be disclosed.
- b. The accused has the right to a written rebuttal, to be reviewed by the Committee.
- c. If the Committee so decides, the flying privileges of the accused will be suspended for thirty (30) days. Written notice of this shall be issued and a copy published in the AGS newsletter.
- (d) THIRD VIOLATION
- a. Committee will notify the accused in writing and the AGS members via the AGS newsletter that the AGS will vote on the expulsion of the accused at the next meeting.
- b. Said expulsion will last for a one-year minimum. (Longer if deemed necessary by the Board of Directors).
- c. A member may be expelled from the AGS only upon a two-thirds (2/3) majority vote of the membership present at the meeting.
- d. Voting will be by secret ballot at a regular monthly meeting.
- e. The expelled member may reapply for membership after the expiration of the expulsion time period.
- (e) The three actions will not be enforced unless they are accumulated within a two-year period of time.
- (f) Any member receiving a Grievance, who directs any retaliation action against the person filing said Grievance, will be subject to immediate expulsion from the AGS. This is to include threats, intimidation,

physical harm, intentional equipment damage, or any other action deemed to be retaliatory by the Board of Directors.

<sup>1</sup>Any member that was exempt from the special assessments due to age before this revision will qualify for the Senior Member dues rate.
