That about does it for this time, and I bid you farewell until next month. Don't forget the July meeting to be held at the AGS field on July 11th. Happy Flying!

Possible Dues Increase on the Way

I know that this will not be a popular subject, but it is my responsibility as your president to keep you informed of any possible changes to the club's operation on a timely basis, and one change that the Board is planning on recommending is an increase to our annual dues structure. At the June Board meeting, Frank Gioffredo stated that the last increase to the annual dues took place in the early 1980's. Anyone who can do math can immediately see that this was more than twenty years ago. And anyone who can do math can immediately see that the cost of living has increased dramatically since then. At an average level of inflation of three percent per year, prices and costs have nearly doubled. In the mean time, our dues have not gone up at all to cover the increased expenses of operating the club.

Since I've been an officer, each year more and more items have been cut from the budget in an effort to make ends meet. The last item of significant expense that was cut from the budget was the printing and mailing of the hardcopies of the Connector to all members. This resulted in a cost savings of over \$1000 per year, and it helped to carry us for a few years. Now we are at the point, however, where there is no more fat to be trimmed from the budget. In addition, we have not been spending any significant funds on road maintenance and this has resulted in the road's deterioration. Something must be done to increase our revenue on an ongoing basis to help the club stay solvent.

At last month's Board meeting, we discussed three options to increase income:

Levy a special assessment. Issue bonds. Increase the annual dues.

Levying a special assessment was not deemed to be a good solution, because it would require all members to come up with a significant amount of money in a lump and this would cause a hardship for some.

Issuing bonds was not seen as a good solution either since the club would ultimately pay out more than it took in due to the fact that the bonds would pay interest to the bond holders.

Increasing the dues seemed to be the best option since it would result in the lowest immediate cost increase to members and would give us some of the extra income that we need as early as October of this year. The Board proposes to increase the dues by \$6.00 per year for each type of membership and to eliminate the \$6.00 savings incentive for members who pay their dues by October 31st. The bottom line is that for those of you who currently pay your dues by the end of October, you will be paying an addition \$1.00 per month for AGS membership. That's only about 25 cents per week on the average and any of us should be able to put a quarter in a coffee can every week to help cover the increase. If you are recalcitrant and always wait to pay your dues until the November time frame, you can throw that quarter into the coffee can every other week. I think that you will all agree that the impact to the membership will be minor.

Right now I can hear some you saying, "Hey, what about all of that money that we're going to make from the logging? Why do we need to increase the dues when we're going to have all of that income?" For one thing, we don't know exactly how much money the timber will bring in. The amount was originally estimated to be between \$5,000 and \$10,000; however, that was when we were thinking of cutting the best trees only, and before we had decided to manage our forest to produce a harvest every ten years or so, to give us long term income. Our take with the present plan may be less than the original estimate. In addition, we will have to pay income tax on the sale of the timber, which will decrease the bottom line even more. And the lion's share of the timber sale will ultimately go to the repair of our road. I don't foresee us having nearly enough money left to tide the club over for another ten years until the next timber sale can take place.

Ultimately, it will be up to you, the membership, to approve the dues increase. However, if this is not done, the only other option will be to continue to erode our bank accounts until there is no money left. At that point, those on the Board at the time will have to work out a plan to dissolve the club and properly dispose of our assets. This would be a rather ignominious end to an organization that was once one of the premiere R/C clubs in the country.

RACING NEWS

The first STRC (Southern Tier Racing Circuit) race was held on May 9 under the leadership of Jerry Roscoe. Seven racers arrived for the 6:30 PM start but only five were able to go to the starting line. The #8 Budweiser plane of Frank Gioffredo had a landing gear leave the wing during the landing of a practice flight and Brent Bryson's plane had battery problems. Don Shugard had an engine failure shortly after takeoff in his first heat and the premature landing damaged his landing gear enough that he was out for the night.

That left only four planes that were able to put in all three of their races. The only Busch pilot, Scott Wallace, had to race the Nextel pilots. Bob Noll's #6 Viagra racer had a cut in the first race giving the win to the #31 Tide Special of Terry Terrenoire. Terry managed to get a cut for himself in his second race but Scott Wallace double cut giving the Tide Special another win. Last year's Busch winner, Jerry Roscoe, did a good job in his first year as a Nextel Cup pilot. Art Riegal could not attend because of an out of town commitment. Jim Quinn has decided not to race this year. Rick Allabaugh had a business engagement out of town.

STRC Race #2 was not held because of high winds. Race #3 was held on June 6. Here are some facts from that race;

Two DNFs in the first race. The racer who was in third place, Don, won the heat, but lost his gear when he landed.

Jim Quinn, our starter for the night, really wanted to be a cut judge so he could blow the horn a few times. Brent still has a transmitter battery on order. When it comes in, he will be ready to race.

Four out of the five racers finished first in at least one heat.

After two races, Nextel has had two different racers in first place. After race 1, Terry was in the lead by one point over Bob (9 points to 8 points). After race 2, Bob is in the lead by one point over Terry (14 points to 13 points). There are only 7 points separating the Nextel fliers and only 2 points separating the Busch fliers. Frank had the most points for the race with 7 points, 1 first place and 2 second place finishes.

Race #4 was scheduled for June 20 but could not be held because not enough helpers showed up. The race 4 organizers did not contact the helpers to remind them of the race and so the hot dogs, chips and soda were the main attraction for the evening.

If you are responsible for organizing a race, please remember to contact those members who have volunteered to help. Not doing so is unfair to the pilots and to those who did get to the field to help.

The next two races are scheduled for July 11 and July 25 and will be organized by Don Shugard.


