Proposed By-laws Change

Current sub-article:

7.10 All Officers and the Newsletter Editor, shall be exempt from paying dues while in office, and the AGS will reimburse the President for his AMA dues. All officers are subject to paying any and all Special Assessments.

Proposed change (in **bold** font):

All Officers and the Newsletter Editor, shall be exempt from paying one-half (1/2) of their dues while in office with the exception of the President who is shall be exempt from paying any dues. All Officers and the Newsletter Editor are subject to paying any and all Special Assessments.

Rationale for the change:

The president will no longer have his/her AMA membership paid for but will continue to have his/her AGS dues paid. The other Officers and the Newsletter Editor will need to pay half their AGS dues. There is a need to decrease the amount of discretionary spending in order to offset some of the increases of our operation costs such as insurance, taxes, and gasoline.

The AGS chapter of the Vintage RC Society will be the hosts for the 17th Annual Spirit of Selinsgrove Reunion the weekend of September 2nd and 3rd at the AGS field. VR/CS Chapter III, The Golden Eagles, are continuing the tradition that was started 17 years ago to commemorate the Pioneers of RC who gathered at Selinsgrove, PA in the 60's to show off the latest in plane and radio designs.

The Vintage RC Society is an AMA Special Interest Group that was formed to preserve and promote the memory of Radio Control Aeromodeling activity and fly planes designed prior to 1970. Modern engines and radios scan be used and the plane can be newly built as long as it is based on a pre-1970 design.

Events for the weekend will include a pattern contest for Class I (rudder only), Class II (rudder and elevator) and Class III (rudder, elevator and ailerons.) Of course throttle control can be used in all classes.

There will also be a Concours event that recognizes the best representation of a vintage plane, and a vintage scale event. The "Design of the Year" is the Class II Falcon 56 by Carl Goldberg. Open flying will be available for those who do not want to compete in any of the events.

Flyers do not have to be a member of the VR/CS to enter so any AGS member who has an old design plane lying around should join the fun. Dust off that Falcon 56 or that deBolt Champ and have some fun.

Flying will start both days at 9 AM and there will be a banquet on Saturday evening at the Treadway Inn in Owego. The event usually end about 3 PM Sunday.

If you aren't able to fly, come and see what we used to fly in the 50's and 60's. There will probably be some planes controlled by rudder only and some interesting "galloping ghost" control systems.


Now it's time to start thinking about our 52nd contest next year!

Intraclub Contest

The Intraclub Contest was held on Saturday, August 26th, 2006. The weather was sunny, warm, dry, calm wind, and an unlimited ceiling, except not at our field where it was cloudy, cool, damp, and breezy with a low cloud cover. We had six brave pilots flying in spite of the conditions. The pilots were Jim Quinn, Terry Terrenoire, Scott Wallace, Jerry Roscoe, Bill Markovitz and Guillermo Leon. Scott Wallace and Doug Breneman ran the contest with help from Rick Curtis. (Thanks, Rick.) The first event was doing roops (as many roll/loop or loop/roll combinations). The second event was doing touch and goes. The third event was a balloon bust. We finished with the Dixie Death (three loops, three rolls, and a spin). The first three events were how many maneuvers could be done in a minute. (Since Jim's plane had lesser performance than the other competitors, he was allotted 90 seconds.) The last event was also timed, but it was the amount of time it took from wheels up to wheels down to complete all of the maneuvers. (Jim was timed for just one of each maneuver.) The contest was very competitive. Scott managed to do 15 roops in just one minute closely followed by Guillermo and Terry who each had 12. Three pilots, Jim, Terry, and Jerry, had 5 touch and goes. The balloon bust was a six way tie. All balloons were left unscathed. Only 250 points (max of 600 points per round) separated the first 4 competitors going into the last round. Terry was able to do the Dixie Death in just 26 seconds. Not to be outdone, Scott followed Terry's run but completed in just 24 seconds. Bill completed in a respectable 34 seconds in his bipe by doing vertical rolls. However, in the end, Terry is our new 2006 Intraclub contest winner. Scott came in second. We had a three-way tie for third place by Jim, Jerry, and Bill. Guillermo just missed also tying for third place by just 50 points. The complete contest results are:

Proposed changes to the AGS By-Laws

Current articles:

Article 3 - MEMBERSHIP

3.1 Regular and Associate Members - All Regular and Associate Members shall be actively interested in radio-controlled aircraft. They must be AMA licensed and FCC licensed if required. All members are expected to fulfill their obligations to the corporation such as committee assignments and assessments. All members shall agree to abide by the AGS by-laws, the AGS field rules, the by-laws of the AMA, and the AMA national model aircraft safety code.

- 3.2 New Members Prospective new members become Associate Members for six (6) months by paying one half (1/2) of the annual dues, one half (1/2) of the initiation fee, as defined in Article 9, and the full amount of any Special Assessment, if required. Associate Members have all rights and duties of Regular Members except voting rights. During the seventh month, his membership shall be discussed and voted upon by secret ballot. Former Members applying for membership shall be immediately eligible for Membership at any regular meeting. A two-thirds (2/3) vote of a quorum (Refer to Article 4 Section 5) shall be required for Regular Membership.
- 3.3 Termination of Membership Involuntary termination of membership shall result, subject to the approval by the Board of Directors, when a member has failed to meet his obligations.

3.4 Student Member - A Regular Member attending school as a full-time student during the dues year. He shall have voting rights only after he has reached eighteen (18) years of age.

3.5 Family Member - A regular Member who is a dependent of and resides in the home of a Regular Member. He shall have voting rights only after he has reached eighteen (18) years of age.

3.6 Senior Member - A Regular Member who becomes sixty-five (65) years old and shall be a member of the AGS for at least ten (10) years during the next dues year.

Article 9 – DUES, FEES, and ASSESSMENTS

9.1 Dues will be imposed upon the members of the AGS in order to meet operating expenses.

9.2 The dues year begins November 1st and ends the following October 31st.

9.3 Dues are to be paid in advance at the October and April meetings. The amount paid at the October meeting is determined by dividing the total amount due (membership plus special assessment, as applicable) in half and rounding up to the nearest dollar, the balance being payable in advance at the April meeting.

9.4 Regular Member dues shall be sixty-six dollars (\$66) per dues year.

9.5 Senior Member dues shall be fifty-four dollars (\$54) per dues year.¹

9.6 Student Member dues shall be eighteen dollars (\$18) per dues year.

9.7 Family Member dues shall be thirty dollars (\$30) per dues year. A Family Member who is a full time student or under the age of eighteen (18) shall pay the same dues as a Student Member.

9.8 The total dues for a family living in the same household shall not exceed ninety-six dollars (\$96) plus special assessments.

9.9 Any Regular Member, excluding Student and Family Members, paying annual dues in full by October 31st will be given a six dollar (\$6) discount.

9.10 As of January 1, 2006, persons applying for membership will be charged an initiation fee of \$100 payable in two installments, the first \$50 paid at the time the person becomes an Associate Member and the second \$50 paid at the time the person becomes a Regular Member.

9.11 Special Assessments may be imposed upon the members of the AGS.² These Special assessments must be for a defined purpose.

9.12 Special Assessments shall be approved by a two-thirds (2/3) majority vote of a quorum at any regular or special meeting following written notification.

9.13 Special assessments will not be levied on Student and Family Members. Initiation fees will not be levied on new Student Members, new Family Members, or former members.

9.14 Any member more than two (2) months delinquent in meeting his financial obligations may be removed from the AGS roles as provided for in Article 3.

9.15 Any dues, fees, or special assessments paid to the AGS will not be refunded.

Proposed Changes: (note changes are in bold font)

Article 3 - MEMBERSHIP

3.1 Regular and Associate Members - All Regular and Associate Members shall be actively interested in radio-controlled aircraft. They must be a current AMA member and FCC licensed if required. All members are expected to fulfill their obligations

to the corporation such as committee assignments and assessments. All members shall agree to abide by the AGS by-laws, the AGS field rules, the by-laws of the AMA, and the AMA national model aircraft safety code.

- 3.3 New Members Prospective new members become Associate Members for six (6) months by paying one half (1/2) of the annual dues, one half (1/2) of the **field maintenance** fee, as defined in Article 9, and the full amount of any Special Assessment, if required. Associate Members have all rights and duties of Regular Members except voting rights. During the seventh month, his membership shall be discussed and voted upon by secret ballot. Former Members applying for membership shall be immediately eligible for Membership at any regular meeting. A two-thirds (2/3) vote of a quorum (Refer to Article 4 Section 5) shall be required for Regular Membership.
- 3.3 Termination of Membership Involuntary termination of membership shall result, subject to the approval by the Board of Directors, when a member has failed to meet his obligations.

3.4 Student Member - A Regular Member attending school as a full-time student during the dues year. He shall have voting rights only after he has reached eighteen (18) years of age.

3.5 Family Member - A regular Member who is a dependent of and resides in the home of a Regular Member. He shall have voting rights only after he has reached eighteen (18) years of age.

3.6 Senior Member - A Regular Member who becomes sixty-five (65) years old and shall be a member of the AGS for at least ten (10) years during the next dues year.

Article 9 – DUES, FEES, and ASSESSMENTS

9.1 Dues will be imposed upon the members of the AGS in order to meet operating expenses.

9.2 The dues year begins November 1st and ends the following October 31st.

9.3 Dues are to be paid in advance at the October and April meetings. The amount paid at the October meeting is determined by dividing the total amount due (membership plus special assessment, as applicable) in half and rounding up to the nearest dollar, the balance being payable in advance at the April meeting.

9.4 Regular Member dues shall be seventy-two dollars (\$72) per dues year.

9.5 Senior Member dues shall be sixty dollars (\$60) per dues year.¹

9.6 Student Member dues shall be twenty-four dollars (\$24) per dues year.

9.7 Family Member dues shall be thirty-six dollars (\$36) per dues year. A Family Member who is a full time student or

under the age of eighteen (18) shall pay the same dues as a Student Member.

9.8 The total dues for a family living in the same household shall not exceed ninety-six dollars (\$96) plus special assessments.

9.9 Any Regular Member, excluding Student and Family Members, paying annual dues in full by October 31st will be given a six dollar (\$6) discount.

9.9 As of January 1, 2006, persons applying for membership will be charged a field maintenance fee of \$100 payable in two installments, the first \$50 paid after the person has been an Associate Member for three months and the second \$50 paid at the time the person becomes a Regular Member.

9.10 Special Assessments may be imposed upon the members of the AGS.² These Special assessments must be for a defined purpose.

9.11 Special Assessments shall be approved by a two-thirds (2/3) majority vote of a quorum at any regular or special meeting following written notification.

9.12 Special assessments will not be levied on Student and Family Members. Field maintenance fees will not be levied on new Student Members, new Family Members, or former members.

9.13 Any member more than two (2) months delinquent in meeting his financial obligations may be removed from the AGS roles as provided for in Article 3.

9.14 Any dues, fees, or special assessments paid to the AGS will not be refunded.


Rationale for the changes:

The name of the initiation fee has been changed to field maintenance fee to better reflect the purpose of this fee. (Articles 3.3, 9.9, and 9.12)

The payment schedule for the field maintenance fee has been changed to allow an associate member to become familiar with our club for three months before half of the field maintenance fee is assessed (article 9.9). This is similar to the AMA Introductory Membership Program which is a three month membership at a cost of \$19.95. This allows a reduced initial cost of joining the AGS, \$52.95 (\$19.95 AMA + \$33 AGS dues) for the first three months. Currently the cost is \$102.95 (\$19.95 AMA + \$33 AGS dues + \$50 AGS initiation fee). After three months, the proposed payment schedule has a payment of \$50 due for the first installment of the field maintenance fee. When an associate member gets voted in as a regular member, the balance of the dues and the second installment of the field maintenance fee are due.

All dues have been increased by \$6 per year (articles 9.4 to 9.7), with the exception of the total family dues of \$96 (article 9.8), and the \$6 discount has been removed (former article 9.9). This is needed to offset some of the increases of our operation costs such as insurance, taxes, and gasoline.
