my answer was, Huh?" he realized that he needed to give me some more information. He explained that all corporations are required to have certain records, and that these should be kept in a Corporate Records book. This book should include the Incorporation Papers, bylaws, copies of resolutions passed by the organization, and other items pertaining to the operation of the corporation. To emphasize the importance of this to me, he told me about a malpractice suit that he had filed for one of his clients against a medical group. The medical group had formed a corporation to protect the individual doctors' personal assets in case of legal judgements against the practice. When Ken investigated further, he found that the doctors did not have any of the required documentation in place and on file. He stated that even though it said "Inc." after the groups name, they were not operating as a corporation, so he also named each of the doctors, personally, in the lawsuit. During our current times, when people sue each other for practically anything...and win...it seemed to me that we had better get our Corporate Records collected and bound as Ken described. So the Board had been working to get our Corporate R cords book assembled. It might save all of us some sleepless nights and elevated pulse rates in the future.

**Logging.**

As you all know, a year ago this past February the club voted to have Two Brothers Logging do some logging work on our property to raise some money to help pay for repairs and improvements to our road. At the time, this seemed like a good idea. However, one of our members, Ed Helinski, contacted me and told me that the way that we were proceeding might not be in the best interest of the club. He recommended that we hire a licensed Forester to manage our forest resources in a manner which would allow us to do periodic harvests and provide an ongoing source of income for the club. In the course of working through the details of this new approach, it came to light that the people doing the logging work would be required by law to be covered by Workman's Compensation Insurance. Ed and several members of the Board checked into this and determined that the best value for the club would be to hire the Forester, have him mark the trees that should be cut, and then sell the trees to a logger before the logging work is begun. Because it is the owner of the trees who is responsible for providing the Workman's Compensation Insurance, the logger would then provide this insurance for his men, and the AGS would not have to buy the insurance, which is very expensive! Some people have been critical of the fact that it has taken a long time to get the logging operation in motion, but since the weather has not been conducive to logging for over a year and a half, there has really been no impact to that work being done.

## **Bylaws updates.**

After I had the meeting with Ken Helisek, I decided that we needed to review our bylaws and update them as required. In my opinion, there were a number of places where we needed to clarify or update items, and we needed to insure that the language was not gender-specific, especially if we wanted to try to achieve tax-exempt status again at some point in the future. I put together a set of updates, and Doug Breneman and Don Shugard have been working on ironing out the final version. Hopefully, it will be completed in the near future.

## **Field Rules.**

After reviewing the Field Rules, it seemed that we also needed to update these as well, especially to clear up some ambiguities and add language to make the rules sound more like a legal document. I feel that this is important, because if we were to have an accident at the field involving a guest, or at Model Aviation Day, we might be called upon to prove in a court of law that we have a clearly defined and strong set of safety rules in place. This may seem like overkill to some, but it's cheap insurance in the case of a lawsuit against us. Doug Breneman and I are going to try to get these completed in the near future.

## **Filing of income tax returns.**

Another issue that came up during my visit with our attorney was the subject of filing yearly income tax returns. I told him that we had not filed a tax return for many years because we believed that we did not have income of a sufficient level to require us to file. Ken said that we should be filing a tax return every year to show the IRS that our corporation still exists and that our income is still below the minimum amount for filing. I and several other board members began looking into this and determined that we do not have to file unless our annual income exceeds \$25,000. After checking with the IRS, I found out that they are now going to require organizations like ours to file a tax return at least once every three years, even if no tax is owed. The Board is going to recommend that the club file a tax return every year to prevent our failing to file in the future. No use having to pay a penalty to the IRS for failing to file, especially when the form is so easy to fill out.

And that about wraps it up, ladies and gentlemen. I hope that you all had a good year and enjoyed your membership in the AGS. And I hope that you'll all be joining up again for 2007. You really need to lend your support and assistance to your officers and board. They will be doing a lot of work for you next year, and I hope that they can count on


