

AEROBATIC PRIMER 2010

AGS AIRPORT July 10~11, 2010 10:00: Instruction 11:30 Lunch 12:00 Flying

To better support all the aerobatic pilots in the NSRCA District I this is a TWO DAY contest, but as in the past it will be for 401, 402, and 403 ONLY! For the last several years this has been an AMA sanctioned contest. The best thing that hasn't change for 2010 is the morning ground school provided by AMA Hall of Fame Bob Noll. Several other aerobatic pilots will also be on hand. Bob will be explaining all the subtleties for best scoring at a contest. We will also use this time for any final trim flying, or maneuver explanations.

Now to the good part, the flying! AMA has NOT issued a new set of maneuvers for the 2010 aerobatic season for Sportsman, Intermediate, and Advanced. The best way to get information about the sequences is to go to the National Society Radio Control Aerobatics' (NSRCA) website, www.nsrca.us. On the home page's left margin there is a title, "Judging Rules" click on it. On the next page in the center, near the bottom will be four links, one for each of the AMA competition classes. Click on your sequence and you will get a wonderful description of each maneuver for each class.

Lastly let me say I hope every member of the AGS comes to the primer. If you currently compete in AMA sanctioned contests as Masters, or FAI come as a judge and helper. Everyone else should come and fly. Bring your favorite airplane, the one you like to fly most often and the one you fly the best. I guarantee you will finish the day a better pilot. You may not come in first place, but you will be a better pilot. We all fly STRAIGHT and LEVEL, or so we think. That is the second maneuver in the Sportsman Sequence, right after TAKE OFF. Flying truly STRAIGHT and LEVEL takes a lot of skill. Come to the contest you will leave a better pilot. OH! Did I mention free food? Actually, it is not free, it is included in the entry fee of \$30.00, but for AGS members that fee is waved!

Proposed by-laws changed regarding dues date changes May 24, 2010

Changes to Article IX

Line B states: The dues year begins November 1st and ends October 31st

Would change Line B to: The Dues year begins January 1st and ends December 31st. All dues are due no later than April 1st. Any dues paid past April 1st would be subject to an additional six dollars (\$6) per month late charge. Anyone in need of special consideration would need to make a request to the board of director for such.

To bring our calendar to correction there would be an addition to the October dues of twelve dollars (\$12) for Regular Members ten dollars (\$10) for Senior Members. As student and minor family members Dues are one dollar (\$1) no addition to their dues would be applied

Proposed By-Laws Changes

Proposal #1

The first proposal deals with three issues facing the club.

The fact that after a person is voted into full membership, they no longer have to do anything that supports the club.

The difficulty in getting people to assist in mowing operations at the field.

The difficulty in getting people to serve as officers or committee chairpersons.

Current Wording:

Article III - MEMBERSHIP

- G. A member in good standing is one who:
 - 1. Maintains membership in the AMA
 - 2. Is current with AGS dues, fees, and assessments
 - 3. Participates in at least one of the activities listed below during the current year:
 - 1. Flies at a club-sponsored event
 - 2. Assists in running a club-sponsored event
 - 3. Serves as an elected officer of the AGS
 - 4. Contributes an article to the AGS newsletter
 - 5. Participates in moving the AGS field or other maintenance operations of the AGS property
 - 6. Participates in a "show-and-tell" portion of a club meeting
- 7. Participates in any other club activity, as published by the Activities Chairperson, which is not mentioned above.

New Wording:

Article III - MEMBERSHIP

<u>G.</u> All AGS members shall be required to participate in at least three activities each year which support the club and its goals. Members are on the honor system to insure that they comply with this requirement. Activities which meet this requirement may be, but are not limited to:

Serving as an officer, Board member, or member of a permanent committee.

Setup and/or presentation at the annual Mall Show.

Helping to support one or more of the STRC races.

Assisting in running a club-sponsored event.

Serving on a field mowing team.

Each AGS member shall be required to work at the annual AMA sanctioned contest if they are able to do so. Working at the contest shall constitute one of the three activities that are required to be performed each year by all members, as noted above.

Each AGS member shall be required to participate in a field moving team if they are physically able to

do so. Club officers, Board members, and chairpersons of permanent committees shall be exempt from the requirement to participate in field mowing. However, they may choose to participate in this activity if they so desire.

Proposal #2

Our by-laws are a legal document that defines how we operate our corporation. Robert's Rules of Order are a highly structured operating procedure. While we generally follow Robert's Rules, we don't do so to the letter. The following change gives us flexibility in running our meetings.

Current Wording

1) Article IV - MEETINGS

All meetings shall be conducted according to Robert's Rules of Order.

New Wording

1) Article IV - MEETINGS

All meetings shall be conducted using Robert's Rules of Order as a guideline.

Proposal #3

The by-laws specify twelve committees. Some of these committees have very little workload. In addition, it is difficult to find people to serve as chairpersons of these committees. The following changes combine some of the committees to reduce the total number.

Current Wording:

Article VIII - COMMITTEES

A. All committees of the AGS shall be appointed by the President and their term of office shall be for a period of one (1) year or less if sooner terminated by the action of the President. The responsibility of each committee shall be defined and documented by the President. The Permanent committees shall be:

- 1. Activities
- 2. Contest
- 3. Field
- 4. Historian
- 5. Librarian
- 6. Membership
- 7. Newsletter Editor
- 8. Nominating
- 9. Program

- 10. Public Relations
- 11. Safety
- 12. Sound

New Wording:

Article VIII - COMMITTEES

All committees of the AGS shall be appointed by the President and their term of office shall be for a period of one (1) year, or less if sooner terminated by the action of the President. The responsibility of each committee shall be defined and documented by the President. The Permanent committees shall be:


- 3. Field

- B. The Finance Committee shall consist of five (5) members the Vice President, the Treasurer, and three (3) regular voting members of the AGS who are not officers. One (1) regular voting member shall be appointed annually to the Finance Committee by the Board of Directors for one three (3) year term.
- C. A nominating committee consisting of three (3) members shall be appointed at least six (6) weeks prior to the Annual Meeting. At least one (1) candidate for each office shall be recommended.
- D. A vacancy in any committee because of death, resignation, removal or any other cause shall be filled in the manner prescribed in these by-laws for regular appointments to such office.

Additional Item

At the present time, we have a library located at G.J.'s Hobby Shop. No one seems to be making use of it. Do we still need to keep the library? If not, why don't we liquidate its contents and delete the position of Librarian from the list of Permanent Committees?
