The Prez Sez

At the last meeting, I brought in my Dynam PBY Catalina for show-n-tell which was going to be my first attempt at flying off of water. Unfortunately, during the first flight, the wings folded in half and it went quickly into the water. I think I was only in the air for less than 2 minutes. After fishing everything out of the water, I inspected the foam where it broke. The break occurred right at the point where the wings met the fuselage. I was surprised to see how thin the foam was and to notice that there was no reinforcement (spar) where the break occurred. I also think that the plastic wing struts failed and pulled away from the fuse. At the meeting, I jinxed myself by saying that I wasn't comfortable with the screws provided with the ARF and how everything was held together with screws. These screws are what held the struts to the fuse. The damage is repairable and I expect to have it ready for the next float fly.

I've done some thinking over the past month and I've decided to stay on as President for one more year. As it stands right now, here is the slate of officers we currently have:

President Allabaugh called the meeting to order at 6:45 PM. Present were 18 club members and one guest, Scott Sinnett. Membership chairman John Carril provided club info to Scott.

Motion made by Bob Balsie to accept last month's meeting minutes as published in the Connector, seconded by Bob Johnson. Filling in for our Secretary and Treasurer, Scott Wallace read the minutes from the last Board meeting and gave the financial report. Questions from the membership concerning financial matters were addressed by Wallace and Allabaugh.

#### **Committee Reports:**

Field: Frank Gioffredo mentioned the tractor/flail mower had been adjusted and would no longer 'scalp' the runways. As always, be vigilant when operating club mowing equipment. Frank also reminded folks to call him should there be equipment issues in need of attention.

Membership: John Carril reported that the AGS has taken in 10 new members this year which is an outstanding result. John also reported we have had four resignations this year.

#### **Activity Reports:**

Bob Balsie gave a promo for the upcoming float fly Sep 6-7. Bob mentioned some great prizes including an ARF seaplane model donated by Maxford USA. Frank Gioffredo gave a promo for the upcoming Aerobatics contest Sep 20-21. Additional helpers are still needed; please contact Frank or Jim Quinn if you are available. Jeff Hatton agreed to serve as judge coordinator.

Historian Don Green gave a report on Model Aviation Day and the VRCS event and had many great photos added to our year in review book.

#### Old business:

President Allabaugh spoke on behalf of the nominating committee (Bob Balsie and Tom Kopl) that we still have open positions for President, Secretary, and Treasurer. If you haven't served on the Board for a few years please consider supporting the club for this vital task.

President Allabaugh stated that club property (large file cabinet, etc.) stored at his place of employment was to have been moved to the field; that has been postponed for now as it can remain at Delta until Dec/Jan timeframe. We will discuss options at the next Board meeting.

#### New business:

President Allabaugh mentioned that Indoor els powered by Thunder Tiger 40's). flying is slated to begin again starting Sept 16 at West Middle School. Requirements are AMA membership and a \$5 fee per session. For additional information please refer to the indoor flying email sent out 9/3, or contact Frank Gioffredo or Jim Ouinn.

We did not have a quorum to vote on the proposed By-Laws changes, however it was agreed upon to discuss the proposals. Two prosed changes will be re-visited and voted on at the October meeting, two other issues were dropped from consideration following discussion highlighted below.

- Jim Quinn questioned the proposed change to Article X concerning the Aerobatics contest, stating we had already voted on this issue recently. Scott Wallace indicated that yes, this issue was raised and defeated in Feb. Proposed change author Bob Balsie stated he didn't realize that we had debated this issue earlier in the year and agreed to withdraw this proposed change.
- Gib Vandling, Tom Kopl, Don Green, Frank Gioffredo, Jeff Hatton, Scott Wallace and several others spoke out against the proposed change to Article XVI concerning filing grievances and member discipline. Rick Allabaugh presented the counter point that the existing policy is vague and this was as effort to clarify the current wording. Gib Vandling made a motion (seconded by Tom Kopl) that we take a 'straw vote' to see if there was any need to revisit the issue next month or drop it. The vote was held and there was an overwhelming majority against this proposed change. Proposed change authors Bob Balsie and Rick Allabaugh agreed to withdraw this proposed change. 
#### Proposed AGS By-Laws Change (submitted by the AGS Board)

At last month's general meeting we did not have a quorum in order to vote on proposed By-Laws changes; hopefully we can address this change at the October meeting.

The AGS Board recommends a By-Laws modification to Article VIII - COMMITTEES regarding the Finance Committee. A Finance Committee shall be a permanent committee convened on an 'as needed' basis and consisting of five (5) members - the Vice President, the Treasurer, and three (3) regular voting members of the AGS who are not officers. One (1) regular voting member shall be appointed annually to the Finance Committee by the Board of Directors for one three (3) year term.

Rationale: Finance Committee was established to 'manage' the large sums of money the club would acquire from gas leases which hasn't happened and isn't likely in the near term. For several years, it has been impossible to staff this committee as written with 3 year commitments. The Committee should be convened on an as needed basis to handle specific tasks, e.g. special assessments, dues increases, property sale discussions, etc.
