Previous Minutes:

Edward Bennett read the previous board minutes. David presented the amended October Board meeting minutes. The October minutes were accepted as amended. Bob Jennings stated the November General meeting minutes needed to be amended to include the Secretary having to cast one ballot for the slate of officers presented and the missing action being added.
